A motion was made by Graham and seconded by Ledbetter to approve the March 5<sup>th</sup>, 2014 special called council meeting minutes as presented and read by the clerk. Motion carried unanimously.

- *Item #1.* A motion was made by Lingerfelt and seconded by Freeman to pass a Proclamation, proclaiming the month of March as American Red Cross Month. Motion carried with all in favor.
- *Item #2.* A motion was made by Lingerfelt and seconded by Graham to partner with the County to take over the management of our tornado sirens. Motion carried with all in favor.

A motion was made by Graham and seconded by Freeman to adjourn. Mayor Jones asked that the motion and the second be rescinded so that Councilmember Lingerfelt is allowed to bring up another item of business. Graham made a motion to rescind this motion and Freeman seconded his motion. Motion carried with all in favor.

*Item #11*. A motion was made by Lingerfelt and seconded by Ledbetter to empower the mayor to sign a contract with Pyrotecnico Fireworks, after he and the city attorney have approved it. Motion carried with all in favor.
