Item #14. A motion was made by Freeman and seconded by Taheri to hire David Holt as the Pool Manager for the City Pool at a rate of \$9.00 per hour. **Motion carried with all in favor.**

Item #15. A motion was made by Rosson and seconded by Freeman to accept the change order issued by Jimmy Traylor Construction and add the purchase and installation of 6 new doors at the Tom Bevill Center for a sum of \$11,700.00. **Motion carried with all in favor.**
