## Regular Council Meeting Monday 5:30 p.m.

The Rainsville City Council met in Regular Session on May 2, 2016, at the Rainsville Agri-Business Center with the following members present: Mayor—Nick Jones. Council Members—Joey Graham, Melissa Ledbetter, and Brandon Freeman. Absent—David Holt.

Mayor Jones called the meeting to order and called the roll.

A motion was made by Graham and seconded by Ledbetter to approve and dispense with the reading of the minutes. **Motion** carried with all in favor.

- **Item #1.** A motion was made by Ledbetter and seconded by Lingerfelt to hire Kevin Smith as a patrolman at the PD effective 5-3-16 and pay will start at the 6 month rate on the pay scale. **Motion carried with all in favor.**
- **Item #2**. A motion was made by Ledbetter and seconded by Graham to promote Sabrina Garmon from PT to FT Dispatcher effective 05-03-16 at the 1 year rate on the pay scale. **Motion carried with all in favor.**
- **Item #3**. A motion was made by Lingerfelt and seconded by Graham to move Cody Kennamer from FT to PT firefighter and to post the FT position internally for 7 days. **Motion carried with all in favor**.
- **Item #4.** A motion was made by Lingerfelt and seconded by Freeman to hire Courtney Hill to fill the PT summer position at the Library. **Motion carried with all in favor.**
- **#5.** A motion was made by Freeman and seconded by Ledbetter to authorize the Mayor to sign the Community Participation Resolution to notify the list of property owners in regards to a possible Demolition Grant in order to see if there is any interest in the project within the community. **Motion carried with all in favor.**
- **Item #6.** A motion was made by Lingerfelt and seconded by Graham to replace the heating/cooling unit at the Library for a sum of \$4658.00. **Motion carried with all in favor.**
- Item #7. A motion was made by Freeman and seconded by Ledbetter to buy 4 benches for the park for a sum of \$1160.00. Motion carried with all in favor.
- **Item #8.** A motion was made by Freeman and seconded by Ledbetter to purchase mattresses for the jail for a sum of \$488.00 paid out of the Corrections Fund. **Motion carried with all in favor.**
- **Item #9.** A motion was made by Freeman and seconded by Graham to purchase four tasers for the PD for a sum of \$3821.89. **Motion carried with all in favor.**
- **Item #10.** A motion was made by Ledbetter and seconded by Freeman to pay FTC a sum of \$650.00 for fiber optics to connect leachate at the WWTP. **Motion carried with Lingerfelt and Graham abstaining due to employment with FTC.**
- **Item #11.** A motion was made by Graham and seconded by Freeman to pay the outstanding B.H. Craig Construction Invoices out of the Special Account/General Fund. **Motion carried with all in favor.**
- Item #12. A motion was made by Graham and seconded by Ledbetter to approve over-time in the Sanitation Dept due to extended hours (M-F—7:00 a.m.-6:00 p.m. & Saturday 10:00 a.m.-6:00 p.m.) for Spring Clean Up through the month of May. Motion carried with all in favor.
- **Item #13.** A motion was made by Graham and seconded by Freeman to authorize a contract with Advanced Engineering regarding the SCADA upgrades at the WWTP for a sum not to exceed \$14,900. **Motion carried with all in favor.**
- Item #14. A motion was made by Graham and seconded by Ledbetter to change the date of the next scheduled Council Meeting from Monday, May 16 to Thursday, May 19 due to the Municipal Conference. The location will be at the Municipal Annex Building beside City Hall. Motion carried with all in favor.
