- **Item #5**. A motion was made by Byrum and seconded by Freeman to accept Wells Street in Hidden Acres Subdivision into the City of Rainsville. **Motion carried with all in favor.**
- Item #6. A motion was made by Freeman and seconded by Rosson to PASS AND ADOPT RESOLUTION 06-19-2017 APPROVING THE AUTHORIZATION BY THE EDUCATIONAL BUILDING AUTHORITY OF THE CITY OF RAINSVILLE OF A TAX-EXEMPT LEASE FINANCING TRANSACTION TO BE ENTERED INTO WITH CORNERSTONE CHRISTIAN ACADEMY. Motion carried with all in favor.
- **Item #7.** A motion was made by Rosson and seconded by Byrum to authorize the Fire Department Hose Testing for a sum of \$1500.00. **Motion carried with all in favor.**
- **Item #8.** A motion was made by Freeman and seconded by Rosson to authorize Melissa Ledbetter to apply for a \$500 grant through AMRV for the Imagination Library. **Motion carried with all in favor.**
