## Mayor Jones called the meeting to order and called the roll.

A motion was made by Graham and seconded by Freeman to approve and dispense with the reading of the minutes. **Motion carried with all in favor.** 

**Item #1.** A motion was made by Graham and seconded by Freeman to hire Zaine Blake as a Patrolman at the Police Department at the starting rate on the pay scale. **Motion carried with all in favor.** 

**Item #2.** A motion was made by Lingerfelt and seconded by Graham to accept the bid of \$397,883.65 from Wiregrass Construction for the paving & striping of RTI Drive, Industrial Blvd, Shiloh Estates, and Chavies Rd. **Motion carried** with all in favor.

Item #3. A motion was made by Freeman and seconded by Lingerfelt to PASS AND ADOPT RESOLUTION 08-01-2016(C) FOR THE SURPLUS OF A 1999 FORD DUMP TRUCK AT THE WASTE WATER TREATMENT PLANT. Motion carried with all in favor.

Motion carried with Freeman abstaining.**

A motion was made by Graham and seconded by Lingerfelt to SUSPEND THE RULES AND PASS AND ADOPT ORDINANCE 08-01-2016 REDUCING THE SPEED LIMIT FROM 40 TO 35 MPH FROM THE INTERSEC-TION OF CHAVIES AND EVERETT TO THE INTERSECTION OF CHAVIES AND FORTNER. Motion carried with a roll call vote: Mayor Jones-yea, Joey Graham-yea, David Holt-yea, Brandon Freeman-yea, Rodger Lingerfeltyea.

**Item #9.** A motion was made by Graham and seconded by Freeman to authorize expenditures associated with the lightning damage to the pump station at Olive Branch at an approximate sum of \$22, 535.00. Damage estimate will also be filed on the City's Insurance policy to recover the expense. **Motion carried with all in favor.**
