A motion was made by Graham and seconded by Lingerfelt to approve and dispense with the reading of the minutes. **Motion carried with all in favor.**

- **Item #1.** A motion was made by Freeman and seconded by Ledbetter to accept the Zoning Board's recommendation and rezone the property on George Wallace from R-2 Low Density Residential to B-3 General Commercial District. **Motion carried with all in favor.**
- **Item #2**. A motion was made by Freeman and seconded by Ledbetter to empower the Mayor to sign the certification presented by Jerry Posey pertaining to The Pines Subdivision. **Motion carried with all in favor.**
- **Item #3**. A motion was made by Ledbetter and seconded by Lingerfelt to hire Anthony Austin as a Patrolman in the Police Dept effective 9-7, and authorize a sum of \$1000 to buy out his contract. **Motion carried with all in favor.**
- **Item #4.** A motion was made by Ledbetter and seconded by Lingerfelt to hire David Snay back as a fulltime Patrolman in the Police Dept effective 9-7 at the 1 year rate on the pay scale. **Motion carried with all in favor.**

- **Item #6.** A motion was made by Lingerfelt and seconded by Freeman to authorize the purchase of fire prevention materials at the Fire Dept for an approximate sum of \$2000. **Motion carried with all in favor.**

- **Item #10.** A motion was made by Holt and seconded by Ledbetter to set a date of 9-12 to conduct a Budget Workshop at 5:00 p.m. to be continued on 9-19 at 4:00 p.m. prior to the Regular Council Meeting if needed. **Motion carried with all in favor.**
- Item #11. A motion was made by Graham and seconded by Freeman to authorize payment of an invoice for the WWTP to Kazmier for \$1,562.32 for the semi-annual calibration of flow meter certification and supplies. **Motion carried with all in favor.**
- Item #12. A motion was made by Graham and seconded by Ledbetter to pay the monthly bills.
