

**ORDINANCE NUMBER 1-10-08
AMENDMENT TO BUSINESS LICENSE CODE SCHEDULE**

**AN ORDINANCE AMENDING THE BUSINESS LICENSE CODE, ORDINANCE
NUMBER 10-15-07 ENTITLED BUSINESS LICENSE CODE OF THE CITY OF
RAINSVILLE, ALABAMA
AMENDING SCHEDULES OF LICENSE FEES**

BE IT ORDAINED BY THE CITY COUNCIL OF RAINSVILLE, ALABAMA, as follows:

SECTION 1. The specific schedules and portions of Section 23, License Fee Schedules, of the Business License Code of the City of Rainsville, Alabama, Ordinance Number 10-15-07 set out and listed by title letter below shall be, and are hereby, amended and replaced with the following language, effective for the fiscal year 2008 and following years unless and until otherwise amended. Those portions and schedules of such Section 23 not set out, listed, and/or amended below shall remain intact as set out in the original ordinance and Section thereof:

“SECTION 23. License Fee Schedules.

Schedule “G” – If gross receipts are:

SECTION 2. All businesses who have paid for their Rainsville business license for the fiscal year 2008 prior to the enactment of this amending ordinance and whose business license fee amount is changed by the changed schedules contained in this amending ordinance shall, within thirty (30) days of the effective date of this ordinance, file with the City a declaration of the new amount alleged to be due and all documentation necessary to show the changed business license fee amount now due from such business pursuant to this amending ordinance. Further, if the business license fee due from such business is increased by the schedules in this amending ordinance, such business shall, within thirty (30) days of the effective date of this ordinance, pay to the City of Rainsville the increase amount due pursuant to this amending ordinance. If the business license fee due from such business is decreased by the schedules in this amending ordinance, the City shall, within sixty (60) days of receipt of the declaration and documentation discussed above, refund to such business the amount of the overage earlier paid to the City by such business.

SECTION 3. The specific classifications and portions of Section 22, License Classifications, of the Business License Code of the City of Rainsville, Alabama, Ordinance Number 10-15-07 set out and listed by title letter below shall be, and are hereby, amended and replaced with the following language, effective for the fiscal year 2008 and following years unless and until otherwise amended:

“SECTION 22. License classifications.


