AN ORDINANCE AFFIRMING AND CONSENTING TO LEASE AGREEMENT WITH THE PUBLIC BUILDING AUTHORITY OF THE CITY OF RAINSVILLE, INC.

WHEREAS, the City of Rainsville (the "City") has entered into a Lease Agreement dated March 22, 2004 (the "Lease Agreement") with The Public Building Authority of the City of Rainsville, Inc. (the "Authority") concerning the leasing by the City of the Agri-Center owned and operated by the Authority;

WHEREAS, pursuant to the terms of the Lease Agreement, the Lease Agreement had an initial term which terminated on September 30, 2004;

WHEREAS, the terms of the Lease Agreement also provide the City with an option to renew the Lease Agreement for 98 successive one year terms beginning October 1 of each year:

WHEREAS, the City wishes to memorialize the renewal of the Lease Agreement and to acknowledge the City's intention to continue to renew the Lease Agreement each year so long as the Authority is indebted to the U.S. Department of Agriculture, or such other holder of the Authority's facility revenue bonds;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RAINSVILLE, Alabama, as follows:

- 1. Ratification of Lease Agreement. The City hereby approves, ratifies and confirms the existence of the Lease Agreement and elects to renew the lease for an additional term ending September 30, 2011. The City acknowledges that the Authority is not currently in default with any of the provisions of the Lease Agreement.
- 2. Expression of Intent. The City hereby memorializes to the U.S. Department of Agriculture, in its capacity as the holder of the Authority's facility revenue bond(s) that the City intends to keep the Lease Agreement in full force and effect subject to the terms set forth in the Lease Agreement, so long as the Authority remains indebted to the U.S. Department of Agriculture.

Adopted this 4th day of October, 2010.

SECTION 2. The specific Schedule "D" and portion of Section 23, License Fee Schedules, of the Business License Code of the City of Rainsville, Alabama, Ordinance Number 10-15-07, as amended, set out and listed by title letter below shall be, and is hereby, amended and replaced with the following language, effective for the fiscal year 2011 and following years unless and until otherwise amended. Those portions and schedules of such Section 23 of Ordinance Number 10-15-07, as amended, not set out, listed, and/or amended below shall remain intact as set out in the original ordinances, amendments, and Sections thereof:


