AN ORDINANCE ASSENTING TO THE ANNEXATION OF PROPERTY CONTIGUOUS TO THE CORPORATE LIMITS OF THE CITY OF RAINSVILLE PURSUANT TO A WRITTEN PETITION BY ALL OWNERS OF REAL ESTATE CONTAINED WITHIN SAID AREA UNDER THE AUTHORITY OF SECTION 11-42-21, 1975 CODE OF ALABAMA AS AMENDED

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RAINSVILLE, ALABAMA, AS FOLLOWS:

SECTION I. The City is in receipt of a written petition by all of the owners of property located and contained within an area contiguous to the corporate limits of the City of Rainsville, which is not located within the corporate limits of any other municipality, petitioning that said real estate be annexed to the City pursuant to the authority contained in Section 11-42-21, 1975 Code of Alabama, as amended. This petition contains an accurate description of the property proposed to be annexed together with a map of the territory showing its relationship to corporate limits of the City. The Council finds said petition to be in the proper form required by the aforesaid section of the Code of Alabama.

**SECTION II.** Pursuant to Section 11-42-21 1975 <u>Code of Alabama</u>, as amended, and the petition filed by the owners of all of the real estate contained within the following territory, the City of Rainsville hereby assents to the annexation of the following described real estate such that the corporate limits of the City of Rainsville shall be extended and rearranged so as to embrace and include this real estate:

The W½ of the NE¼ of the NE¼; all of the SE¼ of the NE¼ W of Town Creek; the SW¼ of the NE¼; and the NW¼ of the NE¼; all in Section 1, Township 7 S, Range 7 E. All that part of the SW¼ of the NW¼ of Section 6, Township 7 S, Range 8 E that lies on the SW side of Town Creek. All in DeKalb County, Alabama.

This real estate is located and contained within an area contiguous to the corporate limits of the City of Rainsville, Alabama, and does not lie within the corporate limits of any other municipality.

**SECTION III.** Pursuant to the requirements of Section 11-42-21 1975 Code of Alabama, as amended, a copy of this ordiance shall be filed with the Probate Court of DeKalb County, Alabama, following the due publication of this ordinance.

**SECTION IV.** This ordinance shall be effective immediately its publication.
