**Item #1.** A motion was made by Graham and seconded by Holt to empower the Mayor to sign the up-dated contract between the City of Rainsville and GEK. **Motion carried with all in favor.**

**Item #2.** A motion was made by Lingerfelt and seconded by Freeman to authorize Ricky Dobbins to purchase a 2011 Ford Escape from the DOT for a sum of \$11,650.00. **Motion carried with all in favor.**

**Item #3.** A motion was made by Lingerfelt and seconded by Ledbetter to adhere to the current Ordinances that are in place concerning the upcoming Municipal Election: **Motion carried with all in favor.**

**Item #6.** A motion was made by Ledbetter and seconded by Freeman to amend **Item #12** in the Minutes from the December 7, 2015 Council Meeting. **Item #12** should state the loan amount as \$1.97 million, rather than \$1.95 million. **Motion carried with all in favor.**

**Item #7.** A motion was made by Ledbetter and seconded by Freeman to authorize the issuance of a tax refund to Bruce Wright of Wright's Equipment in the amount of \$4799.10. **Motion carried with all in favor.**

**Item #8.** A motion was made by Holt and seconded by Freeman to accept the quote of \$1732.00 from Farmers Telephone Coop, and authorize the installation of a security system at City Hall. **Motion carried with Lingerfelt and Graham abstaining due to their employment with Farmers Telephone Coop.**

**Item #9.** A motion was made by Graham and seconded by Ledbetter to **PASS AND ADOPT AN AMENDMENT TO ORDINANCE 02-17-2011 REFLECTING A DECREASE IN THE USE TAX FOR AGRICULTURE AND MANUFACTURING.** Motion carried with a roll call vote: Mayor Jones: yea, Graham: yea, Holt: yea, Ledbetter: yea, Freeman: yea, Lingerfelt: yea

**Item #10.** A motion was made by Graham and seconded by Ledbetter to **PASS AND ADOPT RESOLUTION 02-16-2016 DECLARING THE ACCEPTANCE OF THE DEKALB COUNTY HAZARD MITIGATION PLAN.** Motion carried with all in favor.

**Item #11.** A motion was made by Graham and seconded by Freeman to pay B.H. Craig Construction Estimate # 5 Invoices/Ladd Engineering Invoices out of the Bond Fund with the understanding that the funds will be reimbursed when the Loan/Grant funds become available. **Motion carried with all in favor.**

A motion was made by Lingerfelt and seconded by Ledbetter to pay the monthly bills except for an invoice from Berry & Dunn for the purchase of an executive desk chair for a sum of \$864.00. **Motion carried with all in favor.**

A motion was made by Freeman and seconded by Holt to adjourn the meeting at 5:51 p.m. **Motion carried with all in favor.**
